AVAILABILITY, LOCATION AND METHODS TO SUMMON LAW ENFORCEMENT ASSISTANCE

Availability and Location of Law Enforcement Assistance

The San Diego State University Police Department (UPD), located at 5350 55th Street at SDSU, provides full police services to the campus community 24 hours a day, and seven days a week. You can quickly connect to a police dispatcher by dialing 9-1-1 during an emergency. If you are unable to call, text to 9-1-1 is available in San Diego and Imperial Counties. For non-emergencies, dial 619-594-1991 and select “1” to connect with a police dispatcher. UPD’s peace officers are state police officers who have authority that extends anywhere within the state pursuant to California Penal Code section 830.2(c) and Education Code 89560.

Crime Reporting

Safety is a shared responsibility. In great part, our ability to successfully provide police services relies on campus community members reporting concerning or criminal activity taking place on campus to UPD as soon as possible. When calling, stay on the call and follow the dispatcher’s instructions. You may be asked the following:

- Your name
- Telephone number
- Location of the incident
- Information about any suspect(s)
- Vehicle description(s)
- Last direction of the suspect’s travel (if relevant)

Multiple reporting options are available:

- Dial 9-1-1 during emergencies.
- You may also text 9-1-1 and report your emergency in the message field, however, calling is preferred. Text to 9-1-1 is available in San Diego and Imperial Counties.
- For non-emergency reporting, dial 619-594-1991 and select option “1” to speak with a police dispatcher.
- Download and use the [SDSU Safe app](#) (Apple and Android), which provides information about university support resources, reporting tools and more.
- You may utilize a campus emergency duress phone ([Blue Light Phones](#)) that will connect you directly with UPD police dispatchers.

SPECIAL SAFEGUARDS FOR FACILITIES OR ACTIVITIES

Security of and Access to Campus Facilities

Generally, SDSU facilities are for educational purposes in support of the university mission. The use and restrictions of university facilities is governed by the SDSU Buildings and Grounds Policy, consistent with Education Code 89031. When legally appropriate, persons violating the Buildings and Grounds Policy may be removed per California Penal Code Section 626.6.

Most buildings are locked and secured outside of normal university business hours. Police dispatchers monitor the access control systems of each building, including burglar alarms, motion detectors, panic alarms and unauthorized access alarms. Police officers respond to access control system alarms when activated.

Access to campus residence halls is restricted to residents and registered guests only. Access policies and procedures are regulated by the Office of Housing Administration (OHA). All residential facilities are outfitted with access control measures at each door, and entry point CCTV cameras are also located in public spaces near residential facilities. Upon entering a residential facility, everyone is required to provide a government or university-issued photo identification document. UPD supports the safety and security of all on-campus residential facilities.

Security Considerations Used in the Maintenance of Campus Facilities

Most on-campus buildings and facilities are maintained by Facilities Services (FS), which include deferred and ongoing maintenance and care, fire safety systems, HVAC technologies and water and sewer systems.

FS also maintains building lighting systems, duress phones and alarms – such as panic alarms. These systems are tested and reviewed regularly in collaboration with UPD. Night walks are conducted to examine exterior lighting, and building lights are regularly maintained and repaired. Additionally, there is scheduled maintenance and repairs of fire alarms, fire suppression systems, fire curtains, rolling fire-rated doors and annual fume hood testing and repairs. Door locks and access control readers are also inspected and repaired regularly. For grounds and parking structures, there are tree assessments and scheduled mitigation measures; daily weekday morning walks through parking lots and campus grounds to identify and resolve potential safety hazards before the start of classes; and maintenance of athletic fields to ensure the safety and security of the areas.

ACTIONS TAKEN FROM JULY 2025 TO DECEMBER 2026 TO INCREASE SAFETY

UPD has completed the following safety initiatives:

- Expanded our behavioral health unit, the Psychiatric Crisis Assessment Support Team (P-CAST), with another Licensed Clinical Social Worker
- Hired five additional police officers.
- Hired one additional police dispatcher.
- Hired 10 additional part-time special event police officers to assist with staffing special events at campus venues.
- Increased educational campaigns and community engagement with the public on safety-related topics through our public information officer within UPD.
- Implemented nearly 80% of a new Access Control System (ACS) campus wide utilizing more advanced technologies.
- Upgrade the campus CCTV system to enhance campus safety.
- Expanded the SDSU Safe Ride Program which provides safe, on-campus transportation for students, faculty, and staff during evening hours, Monday through Friday. This program is now managed by Parking & Transportation Services.

CHANGES IN SAFETY PRECAUTIONS EXPECTED TO BE MADE DURING THE NEXT TWO YEARS

From January 2027 to December 2028, UPD is planning to:

- Hire eight police officers to increase UPD's capacity to address safety-related issues.
- Expand the Community Service Officer (CSO) program to increase visibility of uniformed students on campus in support of campus safety.
- Continue implementing a new, campus-wide Access Control System (ACS) utilizing more advanced technologies.
- Expand the Community Safety Specialist (CSS) program to provide extra safety support on campus.
- Expand current CCTV coverage at San Diego and Imperial County locations in support of public safety.
- Expand SDSU Ready Day to include active assailant/active shooter in-person training offerings each fall.

RECORDS OF ON-CAMPUS CRIMES

California Education Code 67380(a)(1)(A)

California State University campuses are required by California Education Code 67380(a)(1)(A) to compile records of all occurrences reported to campus police, campus security personnel or campus safety authorities of, and arrests for, crimes that are committed on campus and that involve violence, hate violence, theft, destruction of property, illegal drugs or alcohol intoxication, and to make this information available within two business days if requested by students, prospective students, employees or members of the media.
